Lessor is **NOT RESPONSIBLE** for any Injuries occurring to lessee or any persons using the leased equipment. Lessee further agrees to hold Lessor free and harmless against any claims and further, Lessor shall be indemnified for any and all cost occurred due to claim from anyone, including court cost and attorney fees. Lessee will provide own liability insurance. Lessee is responsible for the replacement value of the new leased equipment in the event of theft, vandalism, fire or any act that may destroy the leased property.

Reservations – Reservations are recommended before your event. To reserve you must place 50% down, balance due on day of delivery, if you have not paid a deposit there is no reservation.

Delivery and Set up – Delivery Items will require a person of 18 years old to sign for or pick up units. Delivery and Pick up times are not exact. Factor such as traffic and delays with other deliveries may affect your delivery. We try our best to contact our customers in the event of a delay, please allow for such delays.

Inflatable requirements- the following must be met before an inflatable will be set up

An electrical outlet must be located within 100 feet of set up

Inflatable should be set up on a flat surface, slight inclines are ok

If you have underground sprinklers in your yard, please notify us and know where they are

Adequate space is a must; please check if you are ordering a bigger inflatable. The bigger slides are very heavy, where the truck or trailer backs up is where it needs to unload.

Upon set up if the above conditions are not met and we are unable to set up the unit.

No refunds or Credits. If unit has to be moved after set up \$50 reset up fee. If you are not sure the slide will fit in your yard and we are in your area, we will be glad to stop and look.

CANCELLATION POLICY– In the event of rain or hazardous weather, on day of scheduled event customers will be given the opportunity to reschedule the event or given a credit. Phone calls are made to confirm delivery, if upon delivery customers cancel due to rain; we keep your deposit and delivery fee. Once units have been set up no refunds or credits are given.

Rockin C reserves the right to refuse delivery in the event of inclement or hazardous weather, unsafe or unstable conditions. Customers will be given a full refund or credit.

If cancel 30 days prior to contract date customer is due total refund.

No refunds will be given if cancelled 10 days or less from contract date.
